1. RESPONSIBILITIES

1. SMMCHRI agrees to

- Appoint Department of Community Medicine as the Nodal Department in executing this MoU,

2. PYWC agrees to

- Appoint CEO as the Nodal Officer in executing this MoU.

2. TERM

2.1 This MOU shall commence on the Effective Date and shall continue for a period of 5 years, unless terminated earlier by mutual written agreement of the parties.

3. CONFIDENTIALITY

3.1 Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of the collaboration.

4. INTELLECTUAL PROPERTY


4.1 Any intellectual property developed jointly as part of the Collaborative Project shall be jointly owned by both parties, unless otherwise agreed upon in writing.


