### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is entered into as of 1<sup>st</sup> November 2021 between **Sri Muthukumaran Medical College Hospital & Research Institute**, Chikkarayapuram, Near Mangadu, Chennai – 600069 and **Panchayat President**, Katrambakkam Panchayat, Chennai.

WHEREAS, Sri Muthukumaran Medical College Hospital & Research Institute and Katrambakkam Panchayat desire to establish a mutually beneficial relationship for the purpose of collaboration in the field of Corporate Social Responsibility (CSR).

PURPOSE: This Memorandum of Understanding (MoU) outlines the terms and conditions agreed upon between Sri Muthukumaran Medical College, Chikkarayapuram, near Mangadu and the Panchayat President of Katrambakkam Panchayat for the purpose of Corporate Social Responsibility (CSR) initiatives aimed at tree plantation and maintenance of premises to promote greenery in the areas designated as Area A, Area B, and Area C.

Area A: Community Hall Premises Braminal Street at Katrambakkam Panchayat

Area B: Anganwadi Premises Braminal Street at Katrambakkam Panchayat

Area C: Vannankulam and Pappankulam area, MGR Street at Katrambakkam Panchayat

NOW, THEREFORE, the parties agree as follows:

1. SCOPE OF WORK:

1.1 Sri Muthukumaran Medical College and agree to collaborate on tree plantation and maintenance activities within designated areas.

1.2 The designated areas include but are limited to Area A, Area B, and Area C as mutually agreed upon by both parties.

2. RESPONSIBILITIES OF KATRAMBAKKAM PANCHAYAT

2.1 Provide necessary saplings of indigenous tree species suitable for the local environment if possible.

2.2 Ensure the availability of water sources for watering the saplings during the initial growth phase.

3. RESPONSIBILITIES OF SRI MUTHUKUMARAN MEDICAL COLLEGE:

3.1 Provide fencing materials and labour for fencing the designated areas to protect the saplings.

3.2 Undertake the planting of saplings in the designated areas in coordination with the Panchayat authorities.

3.3 Ensure the proper maintenance and care of the planted saplings, including regular watering and monitoring of their growth.

4. DURATION OF AGREEMENT:

4.1 This MoU shall be valid for a period of 5 years, unless terminated earlier by mutual agreement in writing by both parties.

4.2 The duration may be extended upon mutual consent of both parties.

5. MONITORING AND REPORTING:

5.1 Both parties agree to monitor the progress of the tree plantation and maintenance activities regularly.

5.2 Sri Muthukumaran Medical College shall provide periodic reports to the Panchayat President on the status of the planted saplings and any issues encountered during the process.

6. FINANCIAL CONSIDERATIONS:

6.1 Each party shall bear its own costs related to the fulfilment of its obligations under this MoU unless otherwise agreed upon in writing.

6.2 Any additional expenses incurred beyond the scope of this agreement shall be mutually discussed and agreed upon in writing by both parties.
